## **DEMOLITION REQUIREMENTS**

- A. Proof from a certified company or individual capable of conducting an inspection and providing an environmental assessment as to the presence of asbestos and the process to remediate the same, prior to any demolition start-up.
- B. Disconnect Notices from utility companies must accompany application.
- C. After the permit has been issued, the following procedures are to be followed:
  - 1. City of Plaza and/or its agents reserves the right to inspect demolition site(s).
  - 2. All demolition waste is to be transported to landfill or facility as named in the Application.
  - 3. All asbestos should be removed in compliance with the North Dakota Department of Health Asbestos Control Rules.
- D. Completion of Asbestos Notification of Demolition and Renovation Form SSFN 17987 (12/16) if Asbestos is found on or within the building or structure.
- E. All asbestos-containing waste must be properly disposed of in an approved landfill.
  - 1. A waste shipment record (WSR) must be started prior to transportation of asbestos-containing waste.
  - 2. Foundation (concrete, brick, block, etc.) is to be broken into small pieces, no larger than one cubic foot, and transported to a landfill and any foundation excavation shall be compacted and covered within 24" clean fill dirt.
  - 3. All grounds to be re-graded and seeded.
  - 4. The demolition debris must be kept wet enough to prevent dust from emanating from the site. It is the contractor's responsibility to make arrangements with the water company for water from hydrants or to otherwise make arrangements to get water to the site.
